



Price List for Bike Sharing Systems operated by ARRIVA Slovakia a.s.

This price list is valid for the use of Bike Sharing System operated by ARRIVA Slovakia a.s.

Bike sharing systems not operated by ARRIVA Slovakia a.s., or operated by ARRIVA Slovakia a.s.'s cooperation partner implement a price list and GTCs of the respective operator.

§1 Rates

- 1) There is no registration fee for registering via smartphone or online via the operator's website. If the rental is subject to paying a fee and is not free of charge (first 30 minutes of system use), it is necessary to input payment card details before the rental begins. The operator charges a fee of 1,00 € for performing a credit check on the customer. The fee of 1,00 € shall be credited to the account of arriva bike. Subsequently, it shall be cleared during the following payment for bike rental. Based on the service used, the operator is eligible to charge regular rental fees according to the current price list, which can be found online at www.arriva.bike. Registration and login may be done via smartphone app nextbike or online at www.arriva.bike. Only persons older than 16 years of age may become registered customers.
- 2) Normal fare (arriva bike in Nitra): 0,50 € for 30 minutes, 5,00 € for 24 hours.
- 3) Monthly subscription (arriva bike in Nitra): 5,00 € (the subscription fee includes the first 30 minutes free of charge, the following 30 minutes are charged with a valid tariff).
- 4) Annual subscription (arriva bike in Nitra): 25,00 € (the subscription fee includes the first 30 minutes free of charge, the following 30 minutes are charged with a valid tariff).
- 5) Tariff after surpassing the 24 hours CAP (arriva bike in Nitra): 6,00 € for 60 minutes.

§2 Service Fees

The right to charge a higher fee in individual cases, where the costs incurred are higher than the amount listed below, remains unaffected.

- 1) A fee of 10,00 € will be applied if the bike is not used in accordance with the General Terms and Conditions and / or is returned in an excessively polluted condition compared to accepted average.
- 2) A fee of 20,00 € will be applied should the bike not be returned to an official station. Return locations may be found online at www.arriva.bike or via the app.
- 3) Should the bike be returned incorrectly or not be locked correctly, a service fee of 25,00 € shall be applied.
- 4) Should the bike be stolen, customer participation shall be charged with an amount of 75,00 €. The right to compensation for the damage according to the §9 section 2. for Arriva Slovakia a.s. will remain unaffected.
- 5) In case of damage done to the bike/rental station/bike stand, a fee of 75 € shall be charged for actual expenses incurred (material and work). The right to compensation for the damage according to the §9 section 2. for Arriva Slovakia a.s. will remain unaffected.
